## **Mon Jan 25th • Roseau, Dominica • Breakfast, Lunch, Dinner • Wind Surf**

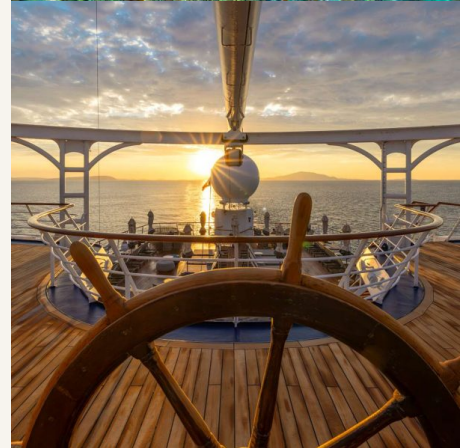
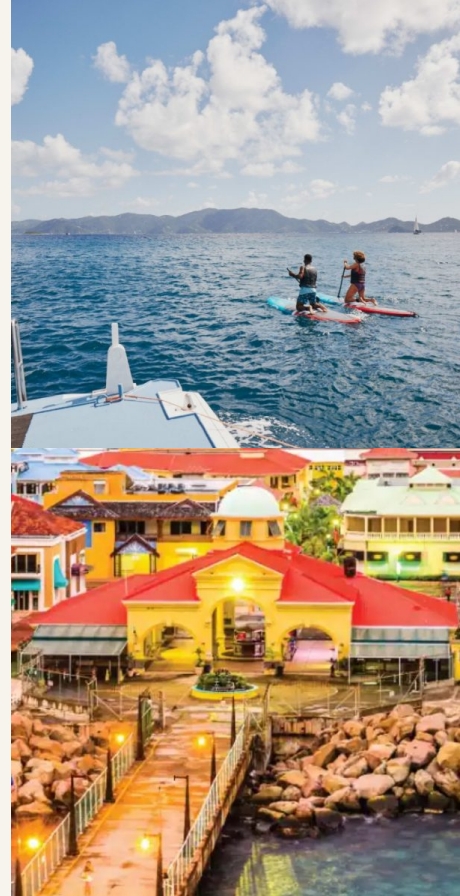

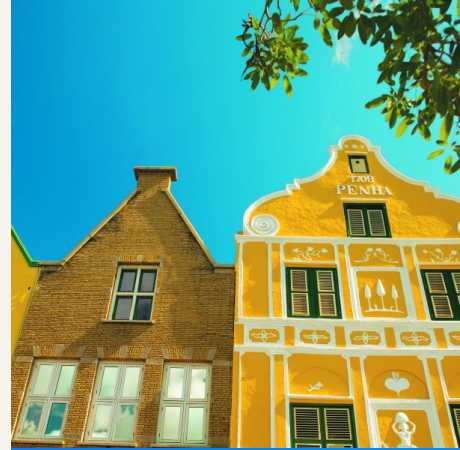

## Cancellation Schedule & Fees:

Original date of deposit to July 1st 2026- \$100 pp non refundable

July 2nd through October 8th 2026- Full deposit is non refundable

Oct 9th through travel dates- up to 100% of vacation package is nonrefundable

Premium Travel Insurance: Refunds are available for cancellations due to covered medical reasons when insurance is purchased through reliable travel insurance companies. These reputable companies offer insurance that both provides excellent coverage even when the covered medical reason might be a pre-existing condition as well as refund of out of pocket expenses while traveling (each insurance company stipulations outlined in their policy and brochure).
